GUJARAT PROVINCIAL MUNICIPAL CORPORATION ACT, 1949.

No. KV/223 of 2013/ELE/102011/3011/P:- WHEREAS, certain draft rules were published as required by sub-section (2) of section 456 of the Gujarat Provincial Municipal Corporations Act, 1949 (Bom. LIX of 1949), at pages 32-1 and 32-2 of the Gujarat Government Gazette, Extra Ordinary, Part I-A, dated the 4th July, 2013 under the Government Notification, Urban Development and Urban Housing Department No. KV/59 of 2013/ELE/102011/3011/P, dated the 4th July, 2013, inviting objections or suggestions from all persons likely to be affected thereby, within a period of thirty days from the date of publication of the said notification in the *Official Gazette*.

AND WHEREAS, no objection or suggestion with respect to the said draft notifications has been received by the Government;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 456 read with sub-section (2) of section 14 of the Gujarat Provincial Municipal Corporations Act, 1949 (Bom. LIX of 1949), the Government of Gujarat hereby makes the following rules further to amend the Bombay Provincial Municipal Corporations (Registration of Electors) Rules, 1994, namely:-

1. These rules may be called the Gujarat Provincial Municipal Corporations (Registration of Electors) (Amendment) Rules, 2013.
2. In the Bombay Provincial Municipal Corporations (Registration of Electors) Rules, 1994 (hereinafter referred to as "the said rules"), for rules 4, 5, 6 and 7, the following rules shall be substituted, namely:-

"4. Preparation and publication of Draft Municipal Electors Roll. -

- (1) The Electoral Registration Officer shall prepare the Draft Municipal Electors Roll in accordance with the provisions of the Representation of People Act, 1951 (43 of 1951) for the time being in force as also the electoral roll of the Gujarat State Assembly, finally published.

- (2) The Draft Municipal Electors Roll shall include the names of all the Persons /voters residing within the geographical limit and shall be displayed in each and every ward of the Municipal Corporation, before two months from the completion of the term of the Municipal Corporation.
- (3) A copy of the Draft Municipal Electors Roll shall be forwarded to the concerned Municipal Corporation for its display in the Main Office as well as all Zonal and Ward offices or any other conspicuous place which may be decided by the Electoral Registration Officer for public inspection.

5. Modification in the Municipal Electors Roll. -

- (1) All names of voters, registered in the electoral roll of the Gujarat State Assembly shall be included in the Draft Municipal Electors Roll till the last date of submission of the candidature for the election of the Municipal Corporation.
- (2) A copy of the supplementary list containing the names of voters shall be forwarded to the Municipal Corporation for its display in the Main Office of the Municipal Corporation or any other conspicuous place which may deem fit by the Electoral Registration Officer, for public inspection.

6. Claim for inclusion in the Municipal Electors Roll. -

- (1) The Draft Municipal Electors Roll for the Municipal Corporation shall be modified in consonant with the relevant part of the electoral roll; of the Gujarat State Assembly till the last date of submission of candidature for the election of the Municipal Corporation.
- (2) The modification to this effect shall be carried out either by the Electoral Registration Officer or on an application which may be made by the applicant in the form as prescribed by the State Election Commission.

7. Publication of Final list of Municipal Electors Roll. -

- (1) No addition or alteration or modification shall be made in the final Municipal Electors Roll after last date of submission of the candidature till the entire process of the election of the Municipal Corporation is completed.
- (2) The Municipal Electors Roll for each ward shall be a conclusive evidence for the purpose of determining whether any person included in such a list shall be entitled to vote at the election from that ward.
- (3) Any person requires printed copy of the final Municipal Electors Roll or the part thereof shall be supplied at the same rate a copy of electoral roll of the Gujarat State Assembly is supplied.
- (4) The Electoral Registration Officer shall supply, free of cost, two copies of the Municipal Electors Roll as finally published alongwith the lists of amendments, if any to every political party recognized for the purposes of the Representation of People Act, 1951 (43 of 1951).
- (5) The Electoral Registration Officer shall send a copy of the final Municipal Electors Roll to the State Election Commission".
