NO. KV 69 of 2009-NPL- 1009 - 4546 -M :- **WHEREAS**, certain draft rules were published as required by sub- section (3) of section 277 of the Gujarat Municipalities Act, 1963 (Guj.34 of 1964) at page 13-1 to 13-2 in the Gujarat Government Gazette, Extraordinary, 1 – A dated 16th April, 2009 vide Government Notification, Urban Development and Urban Housing Department No. KV 32 of 2009-NPL- 1009 - 4546 –M, dated 16th April, 2009 inviting objections or suggestions from all persons likely to be affected thereby, within thirty days from the date of publication of this notification in the Official Gazette.

AND WHEREAS, no objections or suggestions have been received by the Government with respect of the aforesaid draft notification.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 277 read with sub section (2A) of section 9 of the Gujarat Municipalities Act, 1963 (Guj.34 of 1964),. the Government of Gujarat hereby makes the following rules further to amend the Gujarat Municipalities (Registrtation of voters) Rules, 1994 namely :-


1. These rules may be called the Gujarat Municipalities (Registrtation of voters) (Amendment) Rules, 2009.
2. In the Gujarat Municipalities (Registrtation of voters) Rules,1994, (hereinafter referred to as “ the said rules “) in rule 4,

in sub-rule (4), for the words " give notice by advertisement in any two local news papers", the words "affix a notice at his office and at various conspicuous places" shall be substituted.

3. In the said rules in rule 7, in sub-rule (1), in clause (b), for the words " give notice by advertisement in any two local news papers" the word "affix a notice at his office and at various conspicuous places" shall be substituted.
