No-KV/ 7 of 2018/NPL-4513-100-M :- in exercise of the powers conferred by sub-section (1) of section 277 read with sub-section (3) of section 33 of the Gujarat Municipalities Act, 1963 (Guj.34 of 1964), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Municipalities (Reservation of SC , ST , BC and Women for the office of the President) Rules, 1994, namely:-

1. These rules may be called the Gujarat Municipalities (Reservation of SC , ST , BC and Women for the office of the President) (Amendment) Rules, 2018.
2. In the Gujarat Municipalities (Reservation of SC , ST , BC and Women for the office of the President) Rules, 1994. (hereinafter referred to as "the said rules"), in rule 2, for the words and figure "SCHEDULE-7", the words and figure "SCHEDULE-8", Shall be substituted.


