No. KV/64 of 2018/NPL-452017-MP-6/M:- WHEREAS the State Government had notified the areas of the municipal areas of the Morbi Municipality vide Government Notification, Urban Development and Urban Housing Department No. KV/82 of 2015/NPL/452014/5994/M, dated the 6th February, 2015;

AND WHEREAS the resolution was passed by the Morbi Municipality on 3rd October, 2017 so as to exclude the areas of Amreli village (hereinafter referred to as the "said areas") from the part of the Morbi Municipality;


AND WHEREAS the Chief Officer of Morbi Municipality, Prant Officer Morbi Prant and the Collector of Morbi District have also opined to exclude the said areas from the part of the Morbi Municipality;

AND WHEREAS the State Government has considered the said resolution so as to exclude the said areas from the part of the Morbi Municipality;

NOW, THEREFORE, in exercise of the powers conferred by clause (d) of article 243P of the Constitution of India, the Government of Gujarat hereby amends the Government Notification, Urban Development and Urban Housing Department No. KV/82 of 2015/NPL/452014/5994/M, dated the 6th February, 2015, as under:-

In the said notification, in the Schedule, under the heading 'Outgrowth Areas', the entry relating to Amreli village alongwith the Survey numbers as mentioned therein, shall be excluded from the part of the Morbi Municipality.
